	Candidates have three weeks from this slate announcement to the membership to have signatures submitted to support their petition to require a competitive election for the IFT Board of Directors.		
	Signatures will be received and verified by IFT Audit Firm, CliftonLarsonAllen. At the end of the three-week period, the CEO of IFT will notify petitioning candidates whether or not they have reached the necessary threshold to require a competitive election for the IFT Board of Directors.		
	The slate announcement occurred on November 25, 2024, therefore, candidates have until December 16, 2024 to submit this signature form to CliftonLarsonAllen.		
	The number of Premier Members of the Institute at 8:00 a.m. CST on November 25, 2024 was 6,108. A copy of the form must be signed by 5% of Premier Members at the time of the slate announcement. The number of signatures required for a petition to be submitted is 305 (5% of 6,108).

#### **IFT Petition Policy**

This policy was approved by the IFT Board of Directors in March 2021.

Any five percent (5%) of Premier Members of the Institute shall have the privilege of proposing a nominee for President-Elect or IFT Board Member by filing a written petition. Please see the <u>Petition Process & Guidelines</u> for information on submitting a petition to challenge the Board of Directors Slate.

Any candidate brought forth by petition must have submitted and completed their nomination and candidate information form through the online process.

Candidates have three weeks from the slate announcement to submit a petition to the CEO.

If there are no eligible candidates through the petition process, the slate presented to the membership by the Leadership Development Committee shall be deemed elected by the petition deadline and communicated to the membership. An eligible candidate is defined as one who submitted and completed their nomination and candidate information form through the online process.

If one or more eligible petitions have been received by the CEO, an election for the contested position(s) only shall be held. Mail or electronic ballots may be used to conduct the election for contested positions. Nominees (selected by the nomination and the petition process) receiving the greatest number of votes shall be declared elected, provided that a quorum of members (5%) has voted. Tie votes shall be resolved by a majority vote of the members of the Board of Directors.

#### Leadership Election Campaign Guidelines

If one or more eligible petitions are received by the CEO, an election for the contested position(s) only will be held. Should this take place in 2024, an electronic ballot will be utilized. All candidates on the ballot must adhere to the campaign guidelines listed below.

- As a candidate, you are strongly encouraged to take advantage of the webpage on the election website that IFT provides to all candidates by sharing the link or directing members to the page.
- You may use your personal email contact list and personal social media accounts to promote your candidacy.
- IFT will not provide a membership list.
- You may choose to campaign in person at Section or Division activities. The primary goal is to partner with Sections and Divisions to spread the word about the voting process. Should you choose to do so, all associated costs are your responsibility.
- The use of the following IFT communication channels is strictly prohibited which encompasses IFT-related social media including Facebook, LinkedIn, Twitter, Instagram, IFT Section, and Division newsletters/emails, and IFT Connect.
- Candidates are strongly discouraged from issuing press releases, statements, announcements, or other forms of print or online advertising outside of those provided by IFT.
- All candidates are expected to adhere to the <u>IFT Member Code of Professional Conduct</u> and exemplify <u>IFT Core</u> <u>Values</u>.
- The use of the IFT logo is strictly prohibited without the express written consent of the association.
- Any violation(s) can be reported to the Leadership Development Committee Chair for review and discussion.

#### IFT Bylaws – Article VII – Elections

#### Section 7.1 Eligibility for Office

Being appointed or elected to one office shall not make a member ineligible for another office.

#### Section 7.2 Candidates by Nomination

### a) President-elect

The Leadership Development Committee shall select and include on a slate to be presented to the membership, the names of one (1) Premier Member of the INSTITUTE as nominee for President-elect.

## b) Board of Directors

The Leadership Development Committee shall select and include on a slate to be presented to the membership, the name of one Premier Member as nominee for each open position on the Directors of the Board of Directors.

# Section 7.3 Candidates by Petition

Petitions, together with pertinent biographical information and a statement by the candidate, must be filed with the CEO. The deadline for petitions shall be determined by the Board of Directors and communicated to members before the election. Any candidate brought forth by petition must have submitted and completed their nomination and candidate information form through the online process.

a) President-Elect

Any five percent (5%) of Premier Members of the INSTITUTE shall have the privilege of proposing a nominee for President-elect by filing a written petition. The president-elect candidate brought forth by petition must have participated in the official call for nominations in the year in which they are seeking election, and therefore should have a nomination form on file with the Leadership Development Committee. No one will be considered who has not submitted a complete nomination form in accordance with the process.

## b) Board of Directors

Any five percent (5%) of Premier Members of the INSTITUTE shall have the privilege of proposing a nominee for election to the Board of Directors by filing a written petition. No one will be considered who has not submitted a complete nomination form in accordance with the process.

## **Section 7.4 Election Process**

The slate presented to the membership by the Leadership Development Committee shall be deemed elected unless one or more petitions have been received by the CEO which meet the requirements of Section 7.3 hereof.

If one or more petitions meeting the requirements of Section 7.3 hereof have been received by the CEO, an election for the contested position(s) only shall be held, under process approved by the Board of Directors. Mail or electronic ballots may be used to conduct the election for contested positions.

Nominees (selected by the nomination and the petition process) receiving the greatest number of votes shall be declared elected, provided that a quorum of members has voted. Tie votes shall be resolved by a majority vote of the members of the Board of Directors.
